#### **RISK ASSESSMENT GUIDELINES**

Please complete the below assessment and return with your application. If relevant task specific risk assessments & method statements have been completed in the last 9 months, please ford these copies instead.

Please ensure all in-date insurance & hygiene certificates are also sent with your application. If these are due to expire prior to the show, it is your responsibility to ensure we have up to date copies otherwise trading will not be permitted.

### **EXAMPLES**

HAZARD	Slipping/tripping hazards, Chemicals (e.g. battery acid) Moving parts of machinery, electricity, combustible items, working at height, manual handling		
PERSONS AT RISK	Staff, contractors, maintenance personnel, cleaners, members of the public etc. Pay particular attention to inexperienced staff and lone workers

	Intolerable: 20+ Prohibited unless substantial controls implemented
