RISK ASSESSMENT GUIDELINES

Please complete the below assessment and return with your application. If relevant task specific risk assessments & method statements have been completed in the last 9 months, please provide these copies instead.

Please ensure all in-date insurance & hygiene certificates are also sent with your application. If these are due to expire prior to the show, it is your responsibility to ensure we have up to date copies otherwise trading will not be permitted.

EXAMPLES

HAZARD	Slipping/tripping hazards, Chemicals (e.g. battery acid) Moving parts of machinery, electricity, combustible items, working at height, manual handling
PERSONS AT RISK	Staff, contractors, maintenance personnel, cleaners, members of the public etc. Pay particular attention to inexperienced staff and lone workers
EXISTING CONTROLS	Training, Method Statements, Maintenance, Statutory Testing, Guards, Signage, Firefighting equipment
SEVERITY RATING	1 - Minor, 2 – Slight (requires first aid), 3 – Harmful (RIDDOR, non-permanent incapacity), 4 – Major (permanent/long term) incapacity, 5 – Extreme (fatality)
LIKELIHOOD SCORE	1- Highly unlikely, 2 – Unlikely, 3 – Possible, 4 – Likely, 5 Highly likely
RISK LEVEL SCORE	Severity rating x Likelihood Score
RISK LEVEL CATEGORY	Negligible/Tolerable: 1-4 – No further additional controls required
	Moderate/Substantial: 5-16 – Additional controls required
	Intolerable: 20+ Prohibited unless substantial controls implemented
ADDITIONAL CONTROLS If applicable	Training, Method Statements, Maintenance, Statutory Testing, Guards, Signage, Firefighting equipment OR if you consider the remaining residual risk to be adequately controlled without complete elimination
